TRUST DEED

This deed of trust made and executed on this 08th of Nov, 2021 at Thannamandi By 1. Principal, Govt. Degree College Thannamandi (Patron), 2. Muhammad Araf S/o Abdul Rashid (Chairman) 3. Shagufta Faiz D/o Faiz Hussain (General Secretary) 4. Haroon Rashid S/O Abdul Rashid (Accounts Officer) are Executive Committee members of Alumni Association of Govt. Degree College Thannamandi Trust.

Herein after referred to and called as Founder of the Trust which expression will unless repugnant to the context of meaning thereof to be deemed to include their respective, executor, administration of the FIRST PART.

Whereas, the Executive Committee such vice chairman, secretaries, joint secretaries and advisory committee hereinafter referred to as the office bearers as well as advisory committee of the SECOND PART. List of Executive Committee and other office bearers and advisory committee is enclosed and is the part of this trust deed.

Whereas, the board of trustees have agreed to accept the same for its purposes in the manner hereinafter appearing.

1. **NAME OF THE TRUST:** The trust shall be called as Alumni Association of Govt. Degree College Thannamandi Trust.

2. **REGISTERED OFFICE:** Govt. Degree College Thannamandi

3. **AREA OF JURISDICTION:** India

4. **AIMS AND OBJECTIVES OF THE TRUST**

- I. The association shall assist Govt. Degree College Thannamandi, the Alma matter, to achieve its educational goals at par with the ideals of National Education Policy and new Education Policy.
- II. The association shall work for the socio-educational, environ-cultural and scientific development of the area.
- III. The association shall work to provide scholarships to poor and needy students to pursue their studies in dignified manners.
- IV. The association shall work for communal harmony, peace and development of the area.
- V. The association shall work for the conservation of natural environment by way of organizing seminars, conferences and awareness programme in the society.
- VI. The association shall work for eradication of social evils like child marriage, dowry system, sexual harassment and drugs addiction, human trafficking by means of drams/plays, seminars workshops etc.

VII. The association shall work and design youth welfare programme, career counseling and self help groups for the overall welfare of the youths in the area.

VIII. The association shall organize various sports and cultural activities to promote peace and harmony and also contribute in the preservation of indigenous sports and cultural heritages of the area.

5. ARTICLE NO. 1: FUNCTION AND DUTIES OF EXECUTIVE COMMITTEE

I. Composition of Office Bearers. The association shall comprise of following office bearers.

- II. Chairman
- III. Vice Chairman
- IV. General Secretary
- V. Secretaries
- VI. Joint Secretaries
- VII. Account officer
- VIII. Members

1. **Patron:** The Principal of the College shall act as Patron of the association.

2. **Chairman:** Chairman will be supreme authority in the matter of administration. He / She will preside over all the meetings of the association and shall operate the accounts of the association. All members of association will be answerable before the chairman for their work and behavior. Disciplinary action against defaulter will be taken by the chairman.

3. **Vice Chairman:** He / She will represent the chairman in his/her absence. He / She will have all the power vested to chairman except the operation of accounts of the associations.

4. **General Secretary:** He/ She maintain all the records including minute book etc. He/ She shall convene the meetings as and when desired by the Patron/Chairman.

5. **Secretary:** He/ She shall assist the secretary in routine work and will represent general secretary in his/her absence. He / She shall make vide publicity of the activities being undertaken by the association through and social media. There shall be four secretaries including secretary for Socio-cultural affairs, Secretary for environmental concern and secretary for legal affairs, secretary.

6. **Joint Secretary:** He will represent the secretary in his absence and also to perform other assignments whenever assigned to him by the chairman.

7. **Publicity Secretary:** He/ She shall made the vide publicity of events and other programmes whenever organized by the association.

8. **Account Officer:** He/ She will maintain all the records of income and expenditure and get attested by the chairman.

9. **Members:** All the alumni of Govt. Degree College Thannamandi may become the members of trust be filling up the membership form and depositing the life membership fee of Rs. 1000 and ordinary membership of

Rs. 100 which can renewed after every year. However, the membership fee shall be enhanced/reduced in case of Chairman and General Secretary. All members shall actively participate to implements the goals and objectives of the association.

6. ARTICLE NO. 2: ELECTIONS PROCEDURE

- I. The executive committee of the organization consists of not less than five and more than nine members.
- II. The Chairman/General Secretary of the committee shall be elected by means of elections through secret ballot papers. Every members of the committee shall be eligible for the costing the vote to elect the chairman and General Secretary. Both offline and online voting can be done. The term of Chairman/General Secretary and other office bearers shall be three years. The Chairman and General Secretary may nominate the other office bearers of the association in consultation with the patron of the society by democratic means.
